AIGA, working jointly with various National Associations in Asia, successfully held 8 safety seminars in the year 2018.

AIGA is pleased that all the safety seminars saw high quality presentations from some of the experts from AIGA member companies in their respective fields. It was also heartening to note that the seminars in Taiwan and Korea drew more than 200 participants.

- Taiwan Seminar was cosponsored by OSHA and NTUT (National Technical University Taiwan).
- China seminar on Safe Handling of ESG was held jointly with CIGIA what helped to further strengthen the cooperation between the two associations.

AGII Indonesia held the safety seminar on the sides of its'10<sup>th</sup> Congress which was held in East Surabaya after a gap of 8 years.

#### Planned seminars in 2019

In 2019, AIGA continues to work with the national associations to organise safety seminars which could significantly contribute to enhancing safety awareness among people associated with industrial gases industry in Asia region.

AIGA-affiliated associations in China, India, Korea, Taiwan and Singapore have already started planning for safety seminars in their respective countries in the current year with AIGA as co-host.

Safety with manufacturing, storage and handling of Oxygen continues to remain a focus for Gas Industry

and thus India Association have already made plans to hold a safety seminar on Oxygen Safety on 11 Sept 2019 in the city of Hyderabad.

KISGA, Korea have made plans to hold a safety seminar on Electronic and Speciality Gases on 13 Nov in Seoul.

# **International Harmonisation Update**

The four regional associations in USA (CGA), Europe (EIGA), Japan (JIMGA) and Asia (AIGA) met in Hotel Grand Copthorne on Waterfront, Singapore on 26-27 Feb 2019 for the biannual meeting of International Harmonisation Council (IHC). This was the 44th meeting of IHC and was hosted by AIGA. "Observers' from some of the IOMA Global Committee member companies were also present in the meeting.

Milan Sarkar, Secretary General of AlGA Chaired the meeting, which was well attended by 15 delegates from IHC, AlGA TC & Work Groups and other invitees from IGAS, Singapore.

Some of the key items on which the group focussed at the meeting are

- Review of progress with of ongoing harmonisation projects
- > Agree on new work items for harmonisation
- Promoting harmonisation work among various stakeholders

- ➤ How IHC can collaborate with other Standard writing bodies viz ISO, UN, ISBT etc
- Ways to link Harmonisation work with DJSI
- Revise Harmonisation work process to shorten the cycle time of publication work
- New regulatory issues in Europe with inspection of flat bottom tanks

AIGA has been actively supporting the harmonisation work being carried out by IHC by nominating Subject Matter Experts from member companies in the Joint

Work Groups. AIGA also remained committed in promoting the benefits and purpose of globally harmonised standards among member companies, national associations and regulatory authorities in the countries of Asia region.

The next IHC Meeting is scheduled on 21-22 Aug 2019 and will be hosted by the Compressed Gases Association (CGA), in Montreal, Canada. The meeting following the next one will be hosted by JIMGA in Yokohama, Japan in 1Q 2020.



### **Technical Committee & Work Groups**

#### **AIGA Technical Committee Celebrates A Milestone**

The Technical Committee of Asia Industrial Gases Association (AIGA) reached a major milestone when it met for the 50th time 22-23rd January 2019. AIGA Technical Committee oversees and directs programs being carried out by Safety Advisory Group and multiple Work Groups of experts drawn from member companies. The 50th meeting was held with sponsorship of Siam Industrial Gases Association at the Hotel Dusit Princess Srinakarin in Bangkok.

Technical Committee oversees the technical agenda of AIGA. It consists of most senior managers in Health Safety & Environment (HSE) and/or Operations from the member companies in Asia and is currently supported by 7 work groups of experts to focus on specific areas viz General Safety, Transportation, ASU, ESG, Packaged Gases, Medical Gases and Physical Security.

At the 50th meeting, Haris Faroogi, Chairman of Technical Committee, commented "This is indeed a milestone event! I congratulate all current members and thank all the past members for their contribution over last 15 years that helped to develop AIGA activities and publications. I strongly believe AIGA has been effective in making improvements in safety, health and environmental compliance in the industrial gases industry in Asia".

### **Changes in Work Group Representatives from AIGA Members**

There were several changes at the Work Groups during 2018-2019.

In Technical Committee (TC) Zhenxin Qian replaced Hery Liu as member representing Air Liquide (AL). Henry Liu was associated with AIGA TC for nearly 5 years. There was also a change in the membership of TC from TNSC when Toshiaki Kuwano relinquished the membership to Takeshi Yamanishi.

In the Safety Advisory Group, Venkatadas Devisetty (legacy Praxair, now Linde Plc) was elected as the Chairperson in place of Alberic de Mareschal (AL) who relinquished the membership of SAG to Lim Choon Meng after successfully managing the activities as Chairperson and also as a member representing AL for over 4 years. There was also a change in the member from Iwatani as Md Dani has passed on the membership to Wahidin. Md Dani has now been nominated as member of Packaged Gases Work Group.

In Electronic and Speciality Gases Work Group, Wang Bin WU joined as member and as Chairperson in place of Margaret Ang of AL. In ASU & Large Facilities Work Group, Noritake Ikeda replaced Huang Junjie of TNSC and in Packaged Gases Work Group, Phung Eng Wei replaced Tan Chin Tee from TNSC. There was also a change in membership of Medical Gases Work Group when Koujiro Hirao of TNSC relinquished his membership to Wilson Tan.

There were multiple changes in the Transportation WGs as well. Shao Haiyun of Air Products (AP) became a member in Tr WG-A and so is did Eric Cao from Linde Plc. In Tr WG-B there was also change in TNSC representative when **Chanikarn Bakloy** replaced N Pongthep.

AIGA remains grateful to all the outgoing members for their commitment and contributions to the activities and warmly welcomes all the new members in the TC and Work Groups and wishes that their expertise will further enrich the programs of AIGA.

#### **Technical Committee Meetings**

AIGA Technical Committee (TC) has been visiting National Associations (NAs) and jointly holding its triannual TC meetings to network and enhance engagement and cooperation with the Nas.

In 2018-2019 these meetings were held in Taipei City, Bangkok and Kuala Lumpur with the members from THPGIA, SIGA and FMM-MIGMA (the respective country associations for Industrial Gases Industry affiliated to AIGA) who co-hosted the meetings. Face to face meetings with the representatives of National Associations helps AIGA TC understand the current concerns and opportunities with regard to safety and associated regulations in the various countries in Asia.

#### **New Programs**

AIGA Technical Committee and Work Groups have launched several programs and initiatives in the past 12 to 18 months to focus on some of the critical areas of safety. Learning from past accidents and incidents provided the direction required on taking up these initiatives. One such initiative was to focus on High Severity Product Vehicle Accidents (those resulting into roll overs, major human consequence, significant damage to equipment or product release). Regular data collection and analysis provided meaningful insights into the root causes and what preventive/corrective measures can be taken. AIGA believes this work will surely be useful to all associated with transportation of products in Industrial Gases Industry in Asia.

AIGA SAG is also currently working on a project to understand problems with work-related injuries and analysing the data to determine areas to focus to mitigate the risks.

- Use of digital tools to spread the safety communication and publications deeper and faster
- Enhance activities to promote awareness and focus on Process Safety
- > Prevention of injuries related to occupational safety with specific focus on injuries in cylinder handling.

### **National Association Round Up**

## AIGA makes significant progress in setting up of a Representative Office in Vietnam:

AIGA in its endeavour to spread the awareness on safety, health and environment associated with Industrial Gases Industry in Vietnam has been working on establishing a Representative Office in Ha Noi.

MOUs for Collaboration were signed recently by AIGA with VINACHEMIA (Vietnam Chemical Agency) and DWS (Department of Work Safety). The two separate MOUs were with respect of implementation of development assistance activities promoting chemical safety, occupational safety and health in the field of production, distribution and use of industrial gases for the period 2019-2021 between the two key Government Departments of Vietnam and AIGA.

Mr Nguyen Van Thanh, General Director signed one of the MOUs on 13 Feb 2019 on behalf of VINACHEMIA and Mr Ha Tat Thang, General Director, signed the other MOU on behalf of DWS. Milan Sarkar, Secretary General, signed the MOUs on behalf of AIGA in Ha Noi. A pro tem group comprising of representatives from seven Industrial Gases Companies in Vietnam (Air Liquide, Air Water, Linde, Messer, SIG, TOMOE and VJG) has been formed to spearhead the initiatives. AIGA expects to get the Vietnam Rep Office started within the year 2019.

### Updates from AIGA China Representative Office:

In the beginning of 2019 Steven Fang (Linde China) passed on the responsibilities of Chairman of Steering Committee of AlGA China Representative Office to Saw Choon Seong (Air Products China) after successfully leading the activities of the China Rep Office for nearly 5 years.

Liu Lubing of Air Liquide relinquished the position of Chairman of Technical Committee to Shi Kaifei of Linde who was unanimously elected.

AIGA also heartily welcomes **Hangzou Hang Yang** Gases as an Associate Member as they were keen to participate in the activities of China Rep Office by joining the Steering Committee.

Since year 2018, AIGA China have established communication and networking with several key authorities and agencies in the country, who are engaged in drafting safety and technical standards pertaining to Industrial and Speciality Gases. AIGA China members have been able to provide useful technical comments/suggestions during the drafting stage in order to provide the gas industry views and expert opinion.

2019 China ESG Academic Seminar was held in May 13-15 in Wuhan Optics Valley, which was organized by Gas Branch of National Technical Committee on Semiconductor Equipment and Materials of Standardization Administration of China and Hubei Standardization and Quality Institution.

Having been invited to participate for the first time, AIGA contributed two expert speakers to this seminar. The topic "Determination of ESG mixture GHS/GB classification" made by Mr. Huang Hui of Linde Lienhwa China and "SIH4 & NH3 Safety" made by Mr. Fang Song of Air Liquide China got positive feedback from audience.

### Updates from Gas Industries Association India (GIA):

GIA TC under the Chairmanship of Prabuddha Dhar (Linde India) has recently formed a Packaged Gases Work Group in order to focus on areas concerning safety with filling, storage and handling of compressed gases in cylinders. In short span of time the WG has already published three useful documents viz a Training Package on Safety Handling of Portable Cryogenic Containers, a guideline on Minimum Safety Requirement for HP Cylinder Test Station and another guideline on Minimum Safety Requirement of HP Cylinder Filling Station.

# AIGA and IGAS collaboration with Authorities in Singapore and Appreciation for the contributions to Member Company Technical Experts:

Aaron Kalaichelvan (Air Product), as Chairman of IGAS Technical Committee, is working on getting SS639 committee to do a public launch. SS 639: Part 1, 2018 (COP for Filling, Inspection, Testing and Maintenance of Gas Cylinder for the Storage and Transport of Compressed Gases) replaced the old code of practice CP-12. Vutukuru Ramana (Linde Plc), KK Toh (Air Liquide), Tan Chin Tee (Leeden Gases) and Elvin Tham (Air Products) contributed under the convenorship of Thierry Schrimpf (Air Liquid) as experts from Gas Industry who assisted the Technical Committee of SS 639 in the preparation of this standard.

Elvin Tham (Air Products), Vutukuru Ramana (Linde Plc) and Kok Khoon Toh (Air Liquide), all active members of AlGA technical work groups, were presented with a National Merit award by Enterprise Singapore for their contribution to work being carried out by Enterprise Singapore that would help promote product safety among consumers.

Nicholas Yong (Air Products) is currently working with SCIC and other Government bodies in Singapore as convenor for developing LNG TR (Technical Reference). Nicholas is an active member of technical work groups of AIGA and IGAS.

## Updates from Taiwan High Pressure Gas Industries Association (THPGIA)

LU Yung-Cheng of Air Products Taiwan took over the role of Board President of THPGIA from John Miao of Linde Lienhwa. THPGIA has done excellent work in translating and publishing multiple AIGA publications in Chinese. AIGA also reciprocated by providing five speakers at the International Safety Seminar organized by THPGIA at NTUT campus in Taipei on 11 Sept 2018.

# Updates from Korea Industrial and Speciality Gases Association (KISGA)

AirFirst Co became a member of KISGA in May 2019 and is being represented by Li Su Yeon (President) in KISGA Board

In 2018, KISGA in cooperation with Air Products Korea, organised a practical training session on recovery of Tractor Trailer after a roll over. This was a well-coordinated training with practical demonstration by experts.

MIGMA plans to focus on enhancing safety in cylinder transportation by encouraging vertical transportation and also for making compulsory use of cylinder vale caps or guards. MIGMA held a seminar on Safe Use of Compressed Gases' on 23 Oct 2018 in Johor Bahru along with a field demonstration session on "safe handling of Oxy-Acetylene and Liquid Nitrogen Systems at a nearby facility which was found to be quite useful to the participants.
